IN OUR CHURCH

A new series on the principal furnishings of the Church, and their significance.

I - The Altar

The church building as a whole has sometimes been described as essentially 'a covering for the Altar' ; certainly the Altar is the principal item in the church, and should be its focus. In the authoritative *General Instruction of the Roman Missal* we read 'The altar, on which is effected the Sacrifice of the Cross made present under sacramental signs, is also the table of the Lord, to which the People of God is convoked to participate in the Mass, and it is also the centre of

the thanksgiving that is accomplished through the Eucharist.' The *General Instruction* also states that the Altar should be a fixed (rather moveable) structure 'since this more clearly and permanently signifies Christ Jesus, the living Stone', and says that it should be constructed of 'stone, and indeed natural stone'.

When our Sanctuary was re-ordered (was it five years ago?) the horrible black concrete and gravel Altar legs were replaced with natural stone, matching the new Tabernacle pedestal and Lectern. The existing white marble *mensa* (table top) was reused. One or two people asked about having a fabric Altar frontal, or a 'throw over'. But I think a free-standing Altar like ours (the *General Instruction* required that an Altar should be free-standing) looks more dignified without. And certainly seeing the stone enforces the truth that this is a place of sacrifice, and only in a secondary sense a table. On the Altar, the living Christ becomes present, and there hidden under the appearance of bread and wine, is Offered to the Father - the offering or sacrifice which renews the reconciliation which Jesus brought about on the Cross.

The altar is pre-eminently a holy place, which is why it is always appropriate to bow towards the Altar. It is the Throne of Christ, the place where he becomes present in the Holy Sacrament, and from which he feeds his people with his very self.
